CITY EVENT: Any construction activities started along K-15 (Main Street) from the BNSF Railroad (4th Street) through 8th Street shall be closed-up with an ADA compliant surface prior to the scheduled event on May 4th, 2024. A milled roadway surface will also not be allowed.

ADDITIVE BID completion dates will be negotiated, along with the sequence of work to reduce traffic/event impacts, based on the Working days requested.

BIDDER accepts the provisions of the Agreement as to liquidated damages in the event of failure to complete the Work on time.
